Outagamie County Fair - Winter Storage Schedule		
Agreement and payment due	September 15, 2020	Last year's customers have must have agreements and payments in by September 15 to reserve storage space. We will accept new customers and late returned agreements as space is available.
Storage In	October 24, 2020 7:00 AM – Noon	Exceptions may result in additional fees.
Storage Out	April 17, 2021	Property not removed on the "Storage Out" date may incur a late removal fee of \$20.00 plus \$.50/ft per week as determined by OCF.

Reminders

- Bring all storage items through the north Main Street gate. Exit through west gate (Henry St).
- Check-in each item and attach numbered tag.
- Do not leave any items without completing check-in.
- Legibly print your full name and home and mobile phone numbers on a self-supplied luggage tag or I.D. card and attach it to the **trailer hitch** of your item or the front exterior of a car/truck/motor home. Tag must be present at check-in.

2020-2021 Winter Storage Rates:

Outdoor storage \$6.00/linear foot. Please note that you must measure from the **front of your vehicle or trailer (including hitch) to the very back of your item** so an accurate length for storage can be determined and planned for. Length will be verified at check-in (some items have been previously verified). Failure to measure accurately will not allow us to plan accordingly and storage of your item may not be allowed. Extra-wide vehicles in excess of 108 inches wide must add a \$50 surcharge. Thank you in advance for your cooperation.

- **ALL batteries must be disconnected from ALL stored property.**
- Must leave access and ignition keys with OCF for all motor homes and vehicles.
- Boat motors must be up when stored.
- **LATE REMOVAL: \$20 plus \$.50/ft per week. Must call office for all late removal arrangements.**

- OWNERSHIP: This statement certifies that I am the owner of the watercraft(s) and/or vehicles I am storing at the fairgrounds facility located in Seymour, Wisconsin, with the Outagamie County Fair Association, Inc. ("OCF")
- INSURANCE: I certify that I currently have, and during the entire time of storage will have, insurance to cover any damage to my watercraft, camper, and/or vehicles, and to cover my liability for any damages to others or their property arising from any use of such items.
- DAMAGES: I hold harmless the Outagamie County Fair Association and its agents, officers, employees, directors, and volunteers from any and all actions, claims, liabilities, and assertions of liability and/or property damage which in any manner arise or are alleged to arise from any and all activities connected directly or proximately with the storage of my watercraft and/or vehicles with the OCF. **Fair is not responsible for damages.**
- AGREEMENT: I agree that I will abide by all the rules and regulations of OCF. **If I prepay for an inaccurate length, I agree to be billed \$17/foot for the additional length.**
- DATES SUBJECT TO CHANGE: I acknowledge that the storage IN date and the storage OUT date may change due to unforeseen circumstances and my stored item will be inaccessible until all stored items can be removed.
